LIMITED WARRANTY

AiRGO Systems, LLC warrants to the original retail purchaser the Gold and Platinum complete systems solely expressed in this warranty. AiRGO® Systems, LLC is free from parts defects and/or workmanship for Three (3) years from the date of purchase. This three (3) year warranty is limited solely to the Gold and Platinum Series expressed in this warranty and to failures caused by defects in materials and/or workmanship. In the event of such a defect in material and/or workmanship, AiRGO Systems, LLC will be solely responsible for the replacement of those systems.

AiRGO Automatic Tire Inflation System Dealer's or Distributor's are not liable for warranty defects in parts and/or workmanship. All defective parts must be sent back to AiRGO Systems, LLC.

This three (3) year stated warranty includes failure of the retail customer's axle depending upon the part and where it is installed. This warranty is active if the axle was rendered unserviceable solely as a result of the modification of the axle during installation. This warranty only applies if the failed part was installed by an AiRGO Systems, LLC approved "certified" installer in accordance with AiRGO Systems, LLC's recommended installation procedure for any of the above named parts.

In the event of such a defect in material and/or workmanship, AiRGO Systems, LLC will be solely responsible for the replacement of the defective AiRGO® product or products – except that AiRGO Systems, LLC may, at its sole discretion, either repair or replace an axle rendered unserviceable by reason of such installation.

THE FOREGOING WARRANTIES ARE MADE BY AiRGO SYSTEMS, LLC SOLELY TO THE ORIGINAL RETAIL PURCHASER AND ARE IN LIEU OF ALL

OTHER WARRANTIES, EXPRESS OR IMPLIED, STATUTORY OR ARISING BY COURSE OF CONDUCT, DEALING OR PERFORMANCE, CUSTOM OR USAGE IN THE TRADE. THERE IS NO LIMITED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURCHASE, EVEN IF THAT PURPOSE WAS DISCLOSED TO AiRGO SYSTEMS, LLC PRIOR TO THE PURCHASE OF THE WARRANTED GOODS.

The allegedly defective goods must be returned to AiRGO Systems, LLC within ten (10) work days after AiRGO Systems, LLC provides a Return Goods Authorization (RGA) number to the purchaser. The RGA number authorizes the goods return for inspection. AiRGO Systems, LLC has sole discretion as to whether a defective part is replaced or repaired.

AiRGO Systems, LLC shall not be liable, under this warranty or otherwise, for defects or failures of the goods to perform caused by misuse, abuse, improper installation, application or repair or alteration not authorized in writing by AiRGO Systems, LLC. AiRGO Systems, LLC shall not be liable under this warranty, or otherwise, whether in contract or for negligence or other legal fault, for any indirect or consequential damages arising from defects in the goods or for the failure of the goods to perform.
